

# Cookie Policy

The principles for using cookies at the website of Westend Crossing, s.r.o. inform the users of using cookies and similar files governed by EU Directive 2002/58/EC on privacy and electronic communications.

## **Cookies**

In order to ensure proper performance of this website, we store small data files, so-called cookies, on your device. It is a common and useful practice of most large websites. If you continue to browse through our pages without changing the cookies settings in your computer, you consent to storing cookies on your device. Find the details of withdrawing your consent in the “How to control cookies” section.

## **What are cookies?**

Cookie is a small text file stored by a website on your computer or mobile device when browsing through it. Thanks to this file, the website retains information on your steps and preferences (for instance, the language, font size, and other display settings) for a certain period of time, so you do not have to specify it again when browsing through its individual pages.

## **How to use cookies?**

On website [www.westendplazza.sk](http://www.westendplazza.sk) we use cookies within the Google Analytics service that help us adapt the page to your needs. Your privacy is important to us, therefore all these data are anonymous and record neither the user’s personal data nor data which could lead to identification of the person of the user. These data are used for statistical, technical and marketing purposes only.

Using Google Analytics statistics, we can research the views of our pages and information that is interesting for users and which they return to the most. These cookies are analytical, used for creating anonymous overviews of popularity and views of individual pages. The information generated is stored as an anonymous statistic in Google, without the possibility of being allocated to a specific person.

On the customer zone pages ([isod.nafta.sk](http://isod.nafta.sk)), we use cookies to store user session. We use them, for instance, so that the system can log you off for the portal’s security purposes. Similarly, we use cookies for JavaScript identification on the customer zone. Cookies on the customer portal are functional and temporary.

We use cookies for no other reasons than those mentioned above. Individual data are available only to selected employees of Westend Crossing, s.r.o. and to authorised administrator of our web pages.

## **How to control cookies**

Cookies used on our pages are permanent and temporary. Permanent cookies are stored on your device even after leaving our pages; temporary cookies are deleted after leaving a page/closing your browser. You can check and/or delete all cookies at your own discretion. You can delete all cookies stored on your computer or other device, and you can define the settings of most browsers to disable the storage of cookies. Instructions for blocking and

deleting cookies are available on home pages of your browsers. Details on deleting and rejecting cookies and other information regarding these files are available also on website [www.aboutcookies.org](http://www.aboutcookies.org) or [www.allaboutcookies.org](http://www.allaboutcookies.org).

Information regarding the use of cookies in mobile phone browsers and details on rejecting and removing such cookies are available in the manual of your phone or tablet device. Even after blocking cookies, you will be able to visit our pages, however, some functions do not have to work properly. Also, your preferred settings of the website will not be stored, we would not be able to analyse the views of our pages and adapt their settings to users' needs.
